

Privacy Policy

UDDAN has a firm commitment to privacy and to the rights of the holders of personal data, acting in accordance with the provisions of the General Regulation on Data Protection (RGPD) and other applicable legislation.

When using the present website and/or communicating electronically with UDDAN, the personal data of each User is collected and processed, whose processing is regulated by the present privacy policy ("Privacy Policy").

The responsible for the treatment of personal data that the User provides when accessing and using the Site is **Abstractbinary Nau Solutions**, with registered office at Rua Fernando Pessoa, No. 10, Cova da Piedade 2805-139 Cova da Piedade. The User can contact the UDDAN data protection officer through the following e-mail address: info@uddanit.com.

The types of personal data of the Users that we collect and process on the Site and in the Applications are the following:

- IP Address, Cookies and the like. The IP address is a code that identifies the User's internet connection at a specific moment in time, and Cookies are files that are installed in the User's browser and can later be read by the website. However, it is not possible to establish the User's identity with these data, unless the User provides additional information by other means.
- Completion of the contact form. The data collected will be your identification data so that we can reply to your contact.

Users' personal data is collected and processed for the purposes of managing the relationship with UDDAN and when permitted by applicable legislation, for sending information to events within the scope of UDDAN's own professional activities. In addition, your personal data will be collected and processed to provide answers to the questions you send via the contact form.

The legitimacy base for the treatment of the IP address is the need to make possible the connection with the website through the Internet, and it will be the legitimate interest of UDDAN in the case of maintaining the existing relationship with the User, as well as for sending information about UDDAN's activities.

In the case of filling out the contact form and/or registering in events eventually promoted by UDDAN, as well as for Users' requests for information or certain services, the basis of legitimacy shall be the User's own consent.

In the case of data being processed for the purpose of sending communications, the same may be conserved as long as the User does not object to receiving said communications by any of the means that are at his/her disposal.

UDDAN shall not communicate data to third parties, except if strictly necessary for managing and maintaining its relationship with UDDAN, or if it has your prior authorization. In particular, only those third parties to whom UDDAN is contractually or legally obliged to make it available will have access to the personal data.

Furthermore, as a brand with international presence, should it be necessary for the provision of services, UDDAN will be able to communicate its Users' data to the companies that make up the "UDDAN GROUP" for the same purposes indicated above.

In cases of registration in UDDAN events organised with third parties, your data may be shared with these third parties for the organisation and management of the events.

We inform you that Users are entitled to exercise at any time, under the terms established by the legislation in force, their rights to access, rectify or delete data, request that processing be limited, oppose processing, request data portability, as well as revoke the consent given, by writing to Rua Fernando Pessoa, N.º 10, Cova da Piedade 2805-139 Cova da Piedade, or to the email address info@uddanit.com, clearly indicating the right they wish to exercise.

In addition, you may lodge a complaint with the Portuguese Data Protection Commission or other competent data protection authority.

In the event that the User communicates personal data of a third party character, the same guarantees that they have informed us of that communication previously, in the terms indicated in this Privacy Policy, answering personally before UDDAN for the losses and damages that may arise in the case of a violation.
